

**SPECIAL MEETING  
BOARD OF MAYOR AND ALDERMEN**

**June 26, 1996**

**6:30 PM  
Aldermanic Chambers**

Mayor Wieczorek called the meeting to order.

Mayor Wieczorek called for the Pledge of Allegiance; this function led by Alderman Robert.

A moment of silent prayer was observed.

The Clerk called the roll. There were twelve aldermen present.

Present: Aldermen Wihby, Elise, Reiniger, Sysyn, Clancy, Soucy,  
Shea, Domaingue, Pariseau, Cashin, Robert, Hirschmann

Resolution:

"Amending a Resolution 'Appropriating to the Manchester Airport Authority the sum of \$11,273,377 from Special Airport Revenue Funds for Fiscal Year 1997' to \$11,415,964."

On motion of Alderman Sysyn, duly seconded by Alderman Pariseau, it was voted to read by title only and it was so done.

Alderman Clancy moved that the appropriating Resolution pass and be Enrolled. Alderman Pariseau duly seconded the motion. There being none opposed the motion carried.

Resolution:

"Amending a Resolution 'Appropriating to the Central Business Service District the sum of \$270,000 from Central Business Service District Funds for Fiscal Year 1997' to \$282,500."

On motion of Alderman Soucy, duly seconded by Alderman Reiniger, it was voted to read by title only and it was so done.

Alderman Reiniger moved that the appropriating Resolution pass and be Enrolled. Alderman Sysyn duly seconded the motion. There being none opposed the motion carried.

Resolution:

"Amending a Resolution 'Appropriating the sum of \$2,299,094 from Recreation User Charges to the Recreation Division for Fiscal Year 1997' to \$2,353,188."

On motion of Alderman Soucy, duly seconded by Alderman Reiniger, it was voted to read by title only and it was so done.

Alderman Soucy moved that the appropriating Resolution pass and be Enrolled. Alderman Sysyn duly seconded the motion. There being none opposed the motion carried.

Resolution:

"Amending a Resolution 'Appropriating the sum of \$9,437,201 from Sewer User Rental Charges to the Environmental Protection Division for Fiscal Year 1997' to \$9,374,785."

On motion of Alderman Shea, duly seconded by Alderman Reiniger, it was voted to read by title only and it was so done.

Alderman Shea moved that the appropriating Resolution pass and be Enrolled. Alderman Sysyn duly seconded the motion. There being none opposed the motion carried.

Resolution:

"Appropriating to the Manchester Transit Authority the sum of \$900,000 for the Fiscal Year 1997."

On motion of Alderman Soucy, duly seconded by Alderman Pariseau, it was voted to read by title only and it was so done.

Alderman Cashin moved that the appropriating Resolution pass and be Enrolled. Alderman Pariseau duly seconded the motion. There being none opposed the motion carried.

Resolution:

"Amending an Amended Resolution 'Approving the Community Improvement Program for 1997, Raising and Appropriating Monies Therefor, and Authorizing Implementation of Said Program.'"

On motion of Alderman Soucy, duly seconded by Alderman Sysyn, it was voted to read by title only and it was so done.

The Clerk noted that the City Clerk had advised of amendments required based on prior actions of the Board relating to the operating budget as follows:

Amend Table 1-3, City Cash, by deleting the following projects:  
6.10403 Dilapidated Building Demolition -\$50,000  
8.30202 City Hall Roof Replacement -\$40,000  
8.30349 West Library Improvement -\$30,000

Amend Paragraph 2, Page 3, of the Resolution by reducing the amount of municipal funds from \$1,632,810. to \$1,512,810.

Alderman Soucy so moved to amend the resolution as outlined by the Clerk. Alderman Pariseau duly seconded the motion. The motion carried with Alderman Elise duly recorded in opposition.

Alderman Clancy moved that the appropriating resolution pass and be Enrolled as amended. Alderman Shea duly seconded the motion. The motion carried with Alderman Elise and Reiniger duly recorded in opposition. Alderman Reiniger noted that his opposition was based on opposing project 3.30519, the Middle School Program, and wishing to abstain to 2.50626, the Families in Transition Program.

Resolution:

"Amending an Amended Resolution 'Raising Monies and Making Appropriations for the Fiscal Year 1997' so as to Appropriate \$146,727,526."

On motion of Alderman Soucy, duly seconded by Alderman Sysyn, it was voted to read by title only and it was so done.

Alderman Clancy moved that the appropriating Resolution pass and be Enrolled. Alderman Sysyn duly seconded the motion. A roll call vote was taken. Aldermen Robert, Hirschmann, Reiniger, and Domaingue voted in opposition. Aldermen Wihby, Elise, Sysyn, Clancy, Soucy, Shea, Pariseau, and Cashin voted yea. The motion carried.

There being no further business to come before the special meeting of the Board, on motion of Alderman Pariseau, duly seconded by Alderman Soucy, it was voted to adjourn.
