Alderman Hirschmann asked who is going to be in charge of this ISTEA Project B&M Goffstown Branch renovation.

Mr. MacKenzie answered that money is allocated to the Parks, Recreation & Cemetery Department. I also understand that they have been directed to coordinate with the Highway Department on the overall Riverwalk planning and implementation, but at the present time it is at Parks & Recreation.
