Chairman Brack called the meeting to order.

Clerk Pepino called the roll.

Absent: Richard Fradette

Chairman Brack advised that the purpose of the meeting was organizational in nature and that according to the City Charter, Section 5.11(f) Organization. Annually in May before transacting any other business, the Board of Registrars shall appoint one of its members as Chairman and one as Clerk.

City Clerk Bernier stated that according to recent tradition the Chairmanship of the Board of Registrars was done on a rotating basis and suggested that Mr. Brian McHugh be appointed Chairman.

Ms. Pepino moved to appoint Brian McHugh as Chairman of the Board of Registrars. City Clerk Bernier duly seconded the motion. There being none opposed, the motion carried.

City Clerk Bernier stated that as part of the tradition, the outgoing Chairman would then serve as Clerk of the Board of Registrars.

Ms. Pepino moved to appoint Dr. Rita Brack as Clerk of the Board of Registrars. Mr. Brian McHugh duly seconded the motion. There being none opposed, the motion carried.

Newly-appointed Chairman McHugh addressed the voter checklist with respect to new, deleted, or changes made to the voter checklist as of May, 1998.

On motion of Dr. Rita Brack, duly seconded by Ms. Rita Pepino, it was voted to accept the voter checklist as presented to the Board.

Ms. Pepino indicated to the Board that she would forward to the City Clerk's Office a listing of potential voter deletions she had to be checked and deletions made where necessary.

There being no further business to come before the Board on Registrars, on motion of Dr. Rita Brack, duly seconded by Mr. Brian McHugh, it was voted to adjourn.
