Another Person Charged After Belmont ST. Search Warrant Execution

Manchester Police executed a search warrant at 273 Belmont Street on Thursday June 9, 2016. Investigators located the following; 90 grams of crack cocaine (street value \$9,000.00) ; 65 grams of cocaine (street value \$6,500.00); 117 grams of a substance believed to be Fentanyl (street value \$8,000.00); 44 assorted prescription pills (Alrazepam/Lorazepam street value \$125.00) and over \$9,000.00 United States currency.

Investigators applied for an arrest warrant for the leasee, Amanda Gurley, 26 of 273 Belmont Street for Possession of Controlled Drug with Intent to Distribute. Amanda Gurley was arrested approximately 4:30 p.m. yesterday while walking in the area of Concord Street and Maple Street. She was arrested without incident and transported to police headquarters.

She was the fourth person charged in connection with the drugs stored inside of the home. Three individuals arrested last week were also charged with Possession of a Controlled Drug with Intent to Distribute. John Gebo, 30 of 336 Amherst Street and Kelvin Reddick, 33, No Fixed Address, on arrest warrants for Sale of a Narcotic Drug. Brandon Griffin, 28 of 271 Lowell Street was also arrested during the search warrant execution Thursday night during a motor vehicle stop near 273 Belmont Street.

Griffin was charged with Possession of a Controlled Drug and Falsifying Physical Evidence for attempting to conceal the cigarette pack as the officers stopped the vehicle. Reddick, Gebo and Griffin were additionally charged with Possession of a Controlled Drug with Intent to Distribute (Crack Cocaine).The three men appeared in the 9th Circuit Court-Manchester on Monday June 13 for the additional charges.

Gurley appeared in the 9th Circuit Court-Manchester on June 14, 2016.
