### **Queen City Man Charged with Several Drug Charges**

Members of the Special Enforcement Division conducted a motor vehicle stop on S. Main Street at approximately 7:15 a.m. yesterday morning. Detectives arrested the operator, Robert Lesperance, 50 of 175 Conant Street, Manchester, New Hampshire.

Lesperance was wanted for three counts of sale of a controlled drug. The Special Enforcement Division detectives stopped the Toyota Avalon near Hecker Street. A search incident to arrest revealed he was in possession of .4 grams of Crack Cocaine. Lesperance appeared in the 9<sup>th</sup> Circuit Court-Manchester on June 29. He was charged with Possession of a controlled drug, as well as three counts of sale of a controlled drug.



### **Shots Fired on Concord Street**

Manchester Police Detectives spent the majority of the day investigating a shots fired call that occurred approximately 11:25 p.m. last night. The incident occurred on Concord Street, near Dutton Street. Two motor vehicles sustained damage as a result of the gunshots.

Officers arrived on scene and located a 2002 GMC Envoy and a 2002 Saturn Vue parked on Dutton Street, near Concord Street. The Envoy had a single bullet hole in the windshield. The Saturn had several bullet holes on the rear passenger side of the vehicle.

Officers also located several spent shell casing on scene. They eventually towed the two vehicles to police headquarters.
